Do not pursue an enemy who simulates flight; do not attack soldiers whose temper is keen. (Chapter 7)</li><li>- Do not swallow bait offered by the enemy. Do not interfere with an army that is returning home. When you surround an army, leave an outlet free. Do not press a desperate foe too hard. Such is the art of warfare. (Chapter 7)</li></ul>
